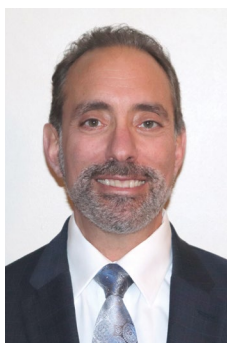

This 30-credit graduate program helps you to build in-depth knowledge of the tax codes, regulations, and Internal Revenue Service (IRS) pronouncements, allowing you to advise individual and corporate clients on a wide range of tax topics. This graduate program can prepare you to:

- › help organizations and individuals file taxes and maintain legal compliance
- › develop tax planning strategies that will lower client tax burden and increase profit
- › conduct research, analyze complex tax laws, and make recommendations
- › gain insight into how the IRS interprets and applies tax law
- › take a probability-driven approach to problem-solving
- › improve your ability to communicate complex tax-related subjects
- › advocate for your clients and resolve conflicts with the IRS
- › practice with the highest of ethical and professional standards

You can complete the Master of Taxation on a part-time basis in as little as 21 months — from anywhere in the world.

Career Opportunities

Graduating with a specialized master's degree in taxation may significantly improve your career trajectory and/or salary potential. You can graduate with the expertise that a more general accounting degree doesn't provide, allowing you to move into a variety of positions, including:

- › Tax Manager or Director

- › Chief Financial Officer

Additionally, students who are not yet CPA-certified may be able to apply credits from graduate-level taxation courses toward the 150-credit requirement to sit for the CPA licensure exam.

Graduate Certificate in Taxation

Course work covers the foundational elements of taxation, research and analysis, corporate and international taxation, and ethical responsibility — all of which are embedded into the curriculum of the master's program. - › begin your education by pursuing the certificate and then step up to a master's degree
- › start with the master's degree and add the certificate along the way

How much is tuition?

Does Penn State World Campus offer financial aid?

Penn State World Campus makes many options available to help you pay for your education. Full- and part-time degree-seeking students are eligible for federal student aid. We also have other options to help you, such as deferred payment plans, third-party payments for employed professionals, and military payment options.

What does the online classroom look like?

Our philosophy for designing online courses: use the latest technology to best deliver the content in the most flexible way while keeping the technology transparent to you. Begin Your Application Today

To be considered for admission, prospective students should submit an online application form and a complete application portfolio. Applications are accepted on a rolling basis.

For the graduate certificate program, you will need to submit:

- › application and fee
- › GPA
- › statement of purpose
- › résumé

For the master's degree program, your application portfolio must include all requirements for the graduate certificate in addition to the following:

- › official transcripts from all institutions attended
- › references
- › TOEFL or IELTS score (if applicable)

GRE/GMAT test scores are NOT required.
